# Red tide still killing dolphins off Florida coast

ORLANDO, Fla. — It's been six months sinc Florida was officially red tide free, but the effects of the last breakout can still be seen in an increased dolphin nortality rate, according to a report by the National Oceanic Atmospheric Administration.

The NOAA reported 174 dolphins have lied between July 2018 and June 20, 2019, in Collier. Lee, Charlotte, Sarasota, Manatee, Hillsborough and Pinellas counties.

The NOAA declared the increased deaths in "unusual mortality event."

Researchers have confirmed through necropsy examinations that several samples tested positive for the red tide tox n, also known as dinoflagellate karenia brevis, indicating that the latest algae bloom has caused an "unusual

related to the "UME."

Red tide hit its stride last year during October and November when algae blooms were found in high concentrations on the west, east and panhandle coasts, causing the death of marine life and respiratory infections.

Red tide exposure

around Florida's coasts is mortality event" in the past, too, the NOAA said. A red tide outbreak be-

tween 2005 and 2006 along the Southwest Florida coast killed 190 dolphins, the NOAA said.

### **Survey indicates Hurricane Michael**

victims forgotten PANAMA CITY, Fla. (AP) — A survey of Floridians is reinforcing the belief among victims of Hurricane Michael that they've been forgotten as they continue their recovery efforts eight months after the Category 5 storm made landfall.

According to the survey of 1,000 Floridians released Wednesday, almost half of respondents said they had no plans to do anything to help victims recover when asked if they would donate money, volunteer time or visit the Panhandle.

The survey says 2 in 5 Floridians believ mistakenly that life has returned to normal in the Panhandle.

The survey was conducted June 7 to June 11 on behalf of Rebuild 850, a coalition of groups dedicated to rebuilding the Panhandle.

Separately, the U.S. Department of Education said Wednesday that it would award a \$1.5 million grant to the county hardest hit by Hurricane Michael to pay for mental health workers in schools.

The department said in a news release that the grant for Bay District Schools would pay for social workers and counselors at each school to help students traumatized by the storm.

### Bank employee sentenced for taking \$171,000 from customer

ORLANDO, Fla. (AP) A 36-year-old Florida bank employee has been sentenced to 23 months in federal prison for stealing more than \$171,000 from a customer.

U.S. Attorney Maria Chapa Lopez announced the sentencing of Reginald Green II on Thursday. A jury found him guilty on theft and embezzlement charges in December.

Prosecutors say Green withdrew more funds than the SunTrust Bank customer had authorized and then put the extra funds in accounts that he controlled. He used the money to pay his mortgage and auto loans.

When the bank discovered the theft in April 2018, Green was fired and the customer was

reimbursed.

The case was investigated by the U.S. Postal Inspection Service and the U.S. Secret Service.

### Man gets 10 years for fatal beating

LAKELAND, Fla. (AP) — A Florida man has been sentenced to 10 years in prison for beating another man to death during a fight.

The Ledger reports that 26-year-old Shaquille Jadon Mothersill was sentenced after pleading no contest last week to manslaughter. He had been facing a second-degree murder charge and possible life sentence.

Lakeland police say 59-year-old Edwin Quinones was fatally beaten last October.

Mothersill told officers after his arrest that he had been playing with his dog when Quinones struck him with a metal crutch. Mothersill said he punched Quinones in retaliation and then continued to punch and kick the other man while he was on the ground.

### Woman wins \$900,000 in civil court from man accused of rape

PENSACOLA, Fla. (AP) — A rape victim won \$900,000 in damages from a civil suit against a maintenance man who used his keys to enter her apartment and attack her.

The victim filed a civil suit against 57-year-old Terry Hamilton and his employer, the Area **Housing Commission** in Pensacola. Hamilton pleaded guilty to burglary and assault charges and was sentenced to five years in prison last November.

The Pensacola News Journal reports the housing commission settled its part of the lawsuit last August, agreeing to pay the woman \$100,000. Hamilton didn't settle, and a jury agreed with the woman's claims of civil battery and intentional infliction of emotional distress.

The woman told police she fell asleep after taking prescription medication when Hamilton used his keys to get into the apartment in March 2017.

### MMA fighter charged in crash that killed 2

PEMBROKE PINES, Fla. (AP) — Mixed martial arts fighter

Desmond Green is facing DUI manslaughter and other charges for a South Florida crash that killed two women last year.

Court records show that Green, who competes as a lightweight for the UFC, was arrested Tuesday in Broward County.

Florida Highway Patrol says Green lost control of his SUV while driving on Interstate 75 near Pembroke Pines in August 2018. It started a chain reaction crash involving five vehicles. Two passengers in one of the other vehicles, 67-year-old Emelina Morfa and 76-year-old Emma Suarez Hernandez, both died. Several others were injured.

Investigators noted tnat Green snowed signs of impairment after the crash and reported finding drugs in his vehicle.

Green's attorney, Jamie Benjamin, says they plan to fight the charges.

Green faces multiple counts of driving under the influence, as well as cocaine possession, marijuana possession and driving with a suspended license. He was being held on \$194,000 bond.

The 29-year-old Green has appeared in seven fights with the UFC since joining the promotion in 2017, going 4-3. He has fought three times for the UFC since the car crash occurred in August 2018.

### Police: Man drugged, assaulted girl, posted naked video

MIRAMAR, Fla. (AP) – Police in South Florida say an 18-year-old man drugged and sexually assaulted a 15-year-old girl he met at a party and posted a naked video of her on Instagram.

Miramar police say Jorge Martinez gave the girl Percocet on Monday and took her to a home where he was staying. An arrest report says later that same evening, some of the girl's friends saw images of her naked body on Instagram.

News outlets report the friends went to the home and found her unconscious. They drove her to a hospital and she was later flown in critical condition to a children's hospital in Miami.

Martinez remains jailed, with a \$550,000 bond. He's charged with sexual battery on a minor.

A lawyer for Martinez isn't listed on jail records.
